Eric asked the Board if there had been any conversation regarding his replacement at the Plant. He had recommendations if no decision had been made to fill the position.

Commissioner Antonucci mentioned that he had reached out to Tim Canavan about filling the vacancy since he currently is working as a floater between transmission and distribution and the plant. Tim was on vacation and did not want to make a decision until he returned to work.

Commissioner Capano asked Eric if he had any recommendations for the position. Eric stated his recommendation for the position would be Dave Waldvogel. Eric indicated he had spoken to the staff at the plant as well as transmission and distribution personnel and Dave was the only one who expressed an interest in taking the position. Eric indicated that a permanent floater would not be the best option. Eric also reminded the Board that Tim had turned down the opportunity to work at the Plant full time in the past due to conflicts with being able to work weekends. Jesse Dutcher, foreman of transmission and distribution would be agreeable to going down to four guys in his department should Dave be transferred to the plant. After discussion, the Board agreed to offer the vacant position at the plant to Dave Waldvogel.

There being no further business, a motion was made by Commissioner Holly, seconded by Commissioner Capano to adjourn the meeting.
