We did advertise for a Request for Qualifications (RFQ) and Anthony opened the (1) RFQ received from C.T. Male Associates and went over it with the Board members.

At this time Andrew wanted to get the Board's permission for him to hire a contractor to put a small addition onto the caretaker house where he currently resides which is owned by the Water Works. Andrew explained that he would like to take out a personal loan for this addition which he received quotes for in the amount of \$20,800 for the addition and an additional \$3,840 for the floors to be re-done. Andrew then asked the Board if they would be willing to cover any portion of this expense. After discussion, the Board decided to forgive one year's worth of rent up to \$3,600 towards these costs. The Board also instructed Anthony to have rental agreements drawn up for both caretakers' houses so everyone can be protected.

Commissioner Antonucci made a motion to allow Andrew White to hire a private contractor to construct an addition onto the caretaker house owned by the Gloversville Water Works on Norboro Road and to approve the suspension of one year of rental payments for Andrew White to equal an amount of no more than \$3,600.00 to cover a portion of improvements to the caretaker house.
